Guests: Dale Alexander, Richland Village Condo maintenance man, commented that the 14 miles per hour speed limit signs in the condo plat had been removed by the Village police without notice to explain the reason for the removal. Chief Mattioli explained that the signs were not legal.

5. Financing the 3 Tahoes in the amount of \$36,000: Barry County to purchase 2 old police cars for \$8,600, Insurance for the totaled 2011 Crown Vic- \$4,700, Drug forfeiture fund - \$6,000, Sale of 2011 Crown Vic - \$8,000. Total of approximate funds to pay for Tahoes - \$27,350 – that is \$8,650 short of total needed.

Action Point:

- 6. Motion to pay for the vehicles from the general fund Briggs/Gross CARRIED
- 7. A spreadsheet is to be created to track the funding of the vehicles to keep the council informed as the money is received.

Discussion:

8. Feedback from the Joint meeting with Richland Township: The Township's information that the police targeted/entrapped patrons of the Pub was not correct. Brinkerhoff presented information, provided by Chief Mattioli that in the past six years they have arrested 6 people for drunk driving that frequented the Pub.

Action Point:

9. Briggs to send email to Al Bussema, Richland Township supervisor, with the correct information regarding the police arrests.

Discussion:

10. Council discussed the health insurance plan and the steps needed to be taken to bring it into compliance with the Affordable Care Act.

Action Point:

11. Insurance committee set up to bring insurance into compliance, explore alternatives to address the matter. Committee members: Bob Prentice, Doug Jonas, Wanda Holewa and Chief Mattioli. They are to report on their findings at the December meeting.

New Business:

Discussion:

12. Review of Police/Richland Township agreement to supply police service to the Gull Lake High School. Is this something that the Village wants to continue? Chief's opinion is that it is not worth the \$250 that the township pays the village for the service. Brinkerhoff pointed out that if a 24/7 police department is in the future that we need to participate with the township. Mattioli suggested that the village should enter into discussion with the township about increasing the fee with the township.

Action Point:

13. Chief to list costs associated with different scenarios for the service. Police committee to meet with the township officials and school administrator.

Discussion:

- 14. Household Hazardous Waste 2014 contract discussed.
- **15.** The Village was given two options for the remainder of the 2013 contract: Pay \$100 so that the village residents can continue to drop off their hazardous waste free of charge for the reminder of the year or the village could pay per resident visit for the remainder of the year.

- Motion to approve the 2014 Household Hazardous Waste contract for the sum of \$500 Jonas/Brinkerhoff – CARRIED.
- 17. Motion to approve spending \$100 for the remainder of 2013 for Household Hazardous Waste.
